

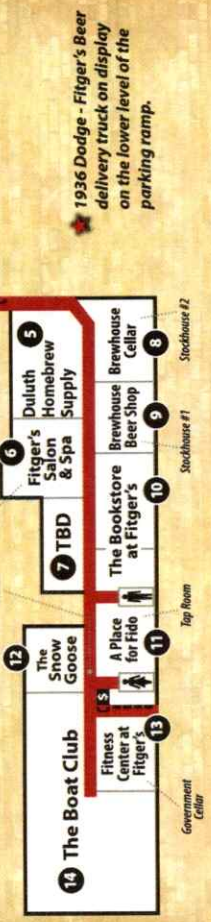

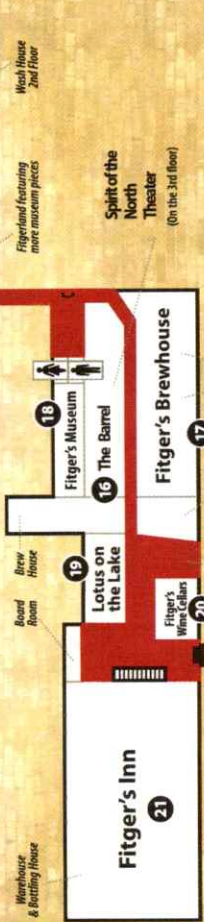

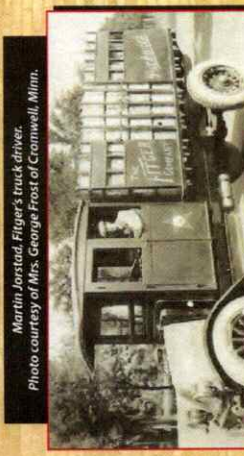
SUPERIOR STREET LEVEL 2ND FLOOR



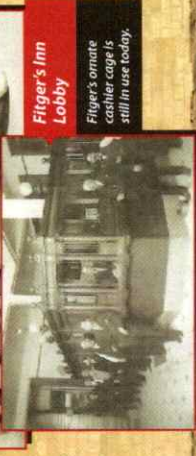
