QUITCLAIM DEED

C.S. 6915 (53=106) Release No. 1498 County of St. Louis

The State of Minnesota having acquired the real estate hereinafter described for trunk highway purposes, and the Commissioner of Transportation of said State having determined that the same is no longer needed by said State for trunk highway purposes, and that the same may be conveyed and quitclaimed to the City of Duluth.

NOW, THEREFORE, Upon said determination and pursuant to Minnesota Statutes, Section 161.16, Subdivision 4, in consideration of the future maintenance, improvement, or reconstruction by Grantee of such roadways, the State of Minnesota, Grantor, by Charles A. No access shall be permitted to Trunk Highway No. 53 from the lands herein described and conveyed in Parcels 226, 226B, 228, 230 and 231 on C.S. 6915 (53=106) 902, except that access shall be permitted between points distant 80 feet and 184 feet northwesterly of the point of beginning of the following described line (measured along said line): Commencing at Right of Way Boundary Corner B6619 as shown on Minnesota Department of Transportation Right of Way Plat No. 69-66 as the same is on file and of record in the office of the County Recorder in and for said County; thence northerly on an azimuth of 00 degrees 57 minutes 10 seconds along the boundary of said plat for 247.67 feet to the point of beginning of the line to be described; thence northwesterly for 279.82 feet on a non-tangential curve, concave to the northeast, having a radius of 2191.83 feet, a delta angle of 07 degrees 18 minutes 53 seconds and a chord azimuth of 317 degrees 23 minutes 52 seconds to Right of Way Boundary Corner B17 as shown on said Plat No. 69-66, and there terminating.
