QUIT CLAIM DEED

For valuable consideration, the City of Duluth, a municipal corporation ("Grantor") herby conveys and quitclaims to the Seaway Port Authority of Duluth ("Grantee"), a body corporate and politic under Minnesota Statutes § 469, real property in St. Louis County, State of Minnesota, described below, together with all hereditaments and appurtenances thereto. The real property described as follows:

See Exhibit A amended attached hereto.

Subject to, and conditioned upon, the following:

The grant of property pursuant to this deed was made pursuant to the consummation of a purchase and sale agreement between Grantor and Soo Line Railroad Company. The terms and conditions of that purchase and sale agreement shall be deemed to be incorporated herein, shall survive execution and delivery of this deed and shall run with the land and be binding upon Grantor and the successors and assigns of Grantee.

As used in this paragraph, "Claims" means any and all liabilities, suits, claims, counterclaims, causes of action, demands, penalties, debts, obligations, promises, acts, fines, judgments, damages, consequential damages, 'losses, costs, and expenses of every kind (including without limitation any attorney's fees, consultant's fees, costs, remedial action costs, cleanup costs and expenses which may be related to any claims); "Environmental Law" means the Comprehensive Environmental Response, Compensation and Liability Act ("CERCLA"), 42 U.S.C. § 9601 et seq., the Resource Conservation and Recovery Act, 42 U.S.C. § 6901 et seq., the Federal Water Pollution Control Act, 33 U.S.C. § 1251 et seq., the Clean Water Act, 33 U.S.C. § 1321 et seq., the Clean Air Act, 42 U.S.C. § 7401 et seq., the Toxic Substances Control Act, 15 U.S.C. § 2601 et seq., all as amended from time to time, and any other federal, state, local or other governmental statute, regulation, rule, law or ordinance dealing with the protection of human health, safety, natural resources or the environment now existing and hereafter enacted; and "Hazardous Substance" means any pollutant, contaminant, hazardous substance or waste, solid waste, petroleum product, distillate, or fraction, radioactive material, chemical known to cause cancer or reproductive toxicity, polychlorinated biphenyl or any other chemical, substance or material listed or identified in or regulated by any Environmental Law. By accepting delivery of this Quit Claim Deed, Grantee, for itself, its directors, officers, agents, affiliates, predecessors, successors and assigns, and anyone acting on its behalf or their behalf covenants and agrees not to sue Grantor or its respective directors, officers, stockholders, divisions, agents, affiliates, subsidiaries, predecessors, successors and assigns, grantors or anyone acting on Its behalf or their behalf with respect to any Claims (including without limitation all Claims arising under any Environmental Law), existing and contingent, known and unknown, that Grantor had, has or may have, whether arising at common law, in equity, or under a federal, state or local statute, rule or regulation, arising out of, resulting from, or relating to the condition of the Property. The foregoing shall apply to any condition of the Property, known or unknown, contemplated or uncontemplated, suspected or unsuspected, including without limitation the presence of any Hazardous Substance on the Property, whether such

Hazardous Substance is located on or under the Property, or has migrated from or to the Property, regardless of whether the foregoing condition of the Property was caused in whole or in part by the Grantor's actions or inactions.

The Soo Line Railroad Company reserved unto itself, and its successors and assigns, a permanent railroad easement in, over, under, and upon that portion of the real property lying within ten (10) feet of the respective center lines of the existing and future railroad tracks, which easement shall be for the operation, maintenance, repair, renewal, replacement, and removal of said tracks and their appurtenances. The easement will be automatically extinguished when the Soo Line Railroad Company, or its successor or assign: (1) exercises lawful authority (under federal, state, or local law) to abandon rail service over the tracks and (2) either physically removes the tracks and appurtenances or gives the City of Duluth (or the City of Duluth's successor, assign, or heir) notice that it intends to abandon the tracks and appurtenances in place. If the Soo Line Railroad Company, or its successor or assign, exercises its option to abandon the tracks and appurtenances in place, such tracks and appurtenances shall thereupon become the property of Grantee in place, and the Soo Line Railroad Company shall have no further liability of any kind regarding same.

The Soo Line Railroad Company reserved unto itself, and its successors and assigns, a permanent easement in, over, under, and upon that portion of the real property lying within 40 feet of the centerline of the existing and future railroad track, for railroad signal and communication purposes, including, but not limited to, the maintenance, construction and repair of signal facilities, poles, wires, utilities, and the right of access thereto at all times.
