**TERMINATION OF
AGREEMENT**

This Termination of Agreement ("Termination") is made as of _____, 2019, by the City of Duluth, a Minnesota municipal corporation (the "City") in favor of Lakeshore, Inc., a Minnesota nonprofit corporation ("Owner").

1. Owner is the owner of certain real property located at 3900 London Road, in the City of Duluth, County of St. Louis, State of Minnesota, as more particularly described in Exhibit A attached hereto (the "Property").

2. An assessment agreement, assessing charges for the extension of water and gas mains to the Property, by and between the Board of Water and Light Commissioners of the City of Duluth and the then owners of the Property, was filed on March 9, 1907, in Book 4 of Agreements Page 208, as Document No. 101470, in the office of the St. Louis County Register of Deeds (the "Agreement").

3. The City hereby acknowledges that the obligation referenced in the Agreement has been fully satisfied and City and Owner agree that the Agreement is hereby terminated. The City consents to the removal of the Agreement as a recital on Certificate of Title No. 331912. Owner may file this Termination in the office of the Registrar of Titles of St. Louis County, Minnesota. Upon such filing, the Registrar of Titles may remove the Agreement as a recital on Certificate of Title No. 331912 for the Property.

4. This Termination may be signed in two or more counterpart copies with the same effect as if the signature to each counterpart copy were on a single instrument. Each counterpart shall be deemed an original as to any party whose signature it bears and all such counterparts shall constitute one document.
