At the age of 15, I was my school's representative to Youth Civic Forum, a year-long program that met weekly to educate teens about city government. At the culmination of the program, my peers elected me Water and Sewage Treatment Director which I proudly served for one-week in June. The treatment facility preceded the Sanitary Sewer Board of the WLSSD, but served a similar function with much less modern techniques.

While serving on the Duluth City Council from 1988-2000, our council debated and adopted precedents to current recycling, solid waste removal and storm water separation policy (sump pump and roof drainage).

While serving in MN state elected office from 2002-2015, I actively sponsored and advocated for WLSSD legislation that bonded for remedies to comply with and abate further constraints of the consent decree. I also chaired the senate energy committee and authored nation-leading renewable energy, conservation and carbon reduction legislation. I held at least monthly meetings with the MN PUC to review rates, policy and obstacles to progress. These experiences prepare me to be a helpful resource as WLSSD embarks on a journey toward energy neutrality.

I have served as a member and officer on dozens of boards. I was a clinical psychologist by training and profession and have education, experience and success in group dynamics and board membership.
