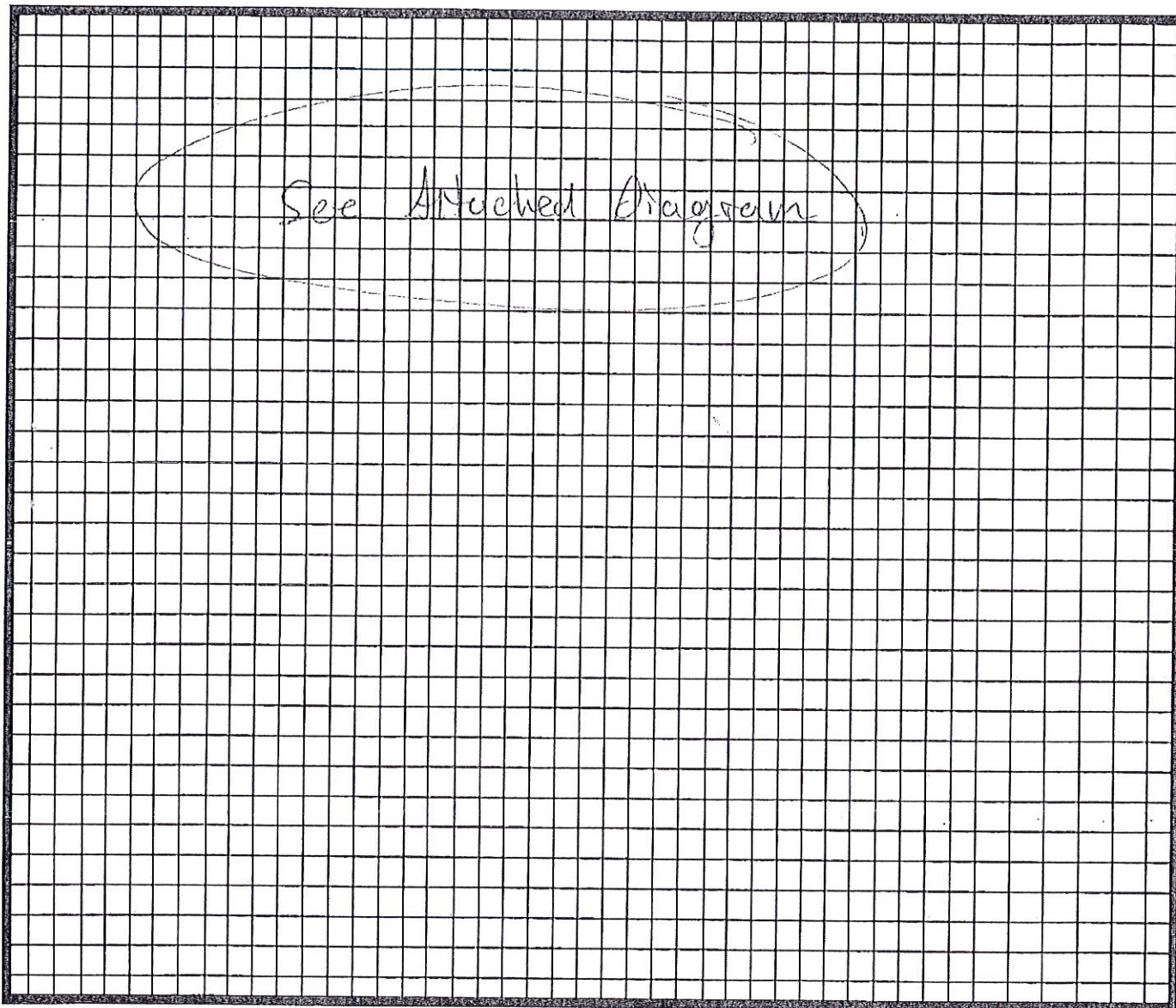

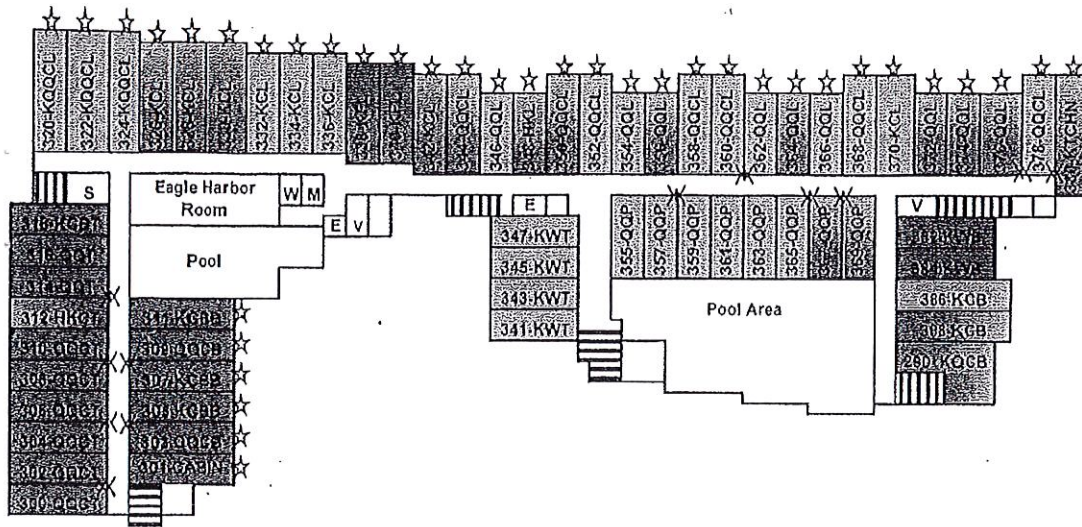
PERMANENT EXPANSION OF DESIGNATED SERVING AREA SITE PLAN



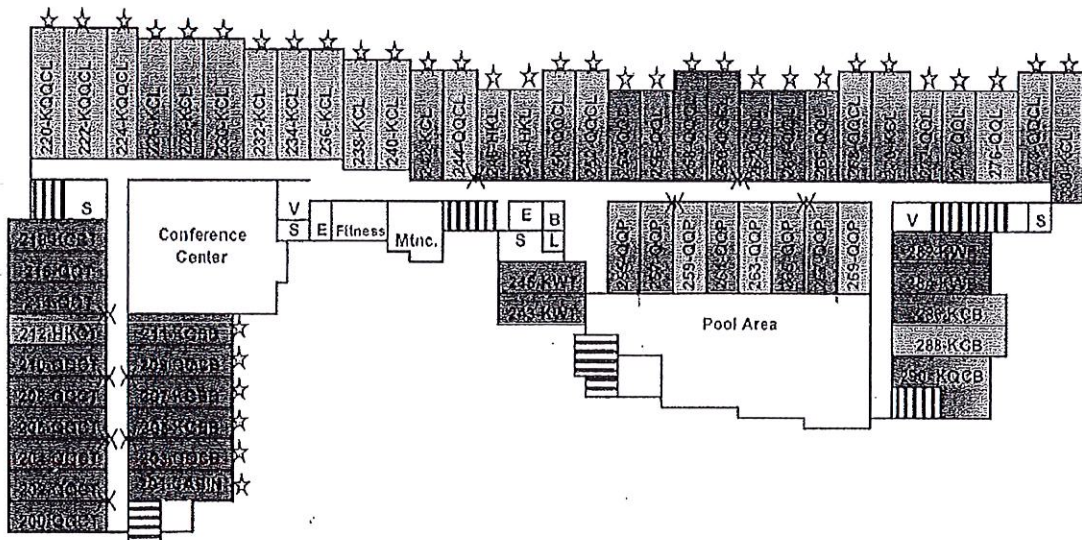

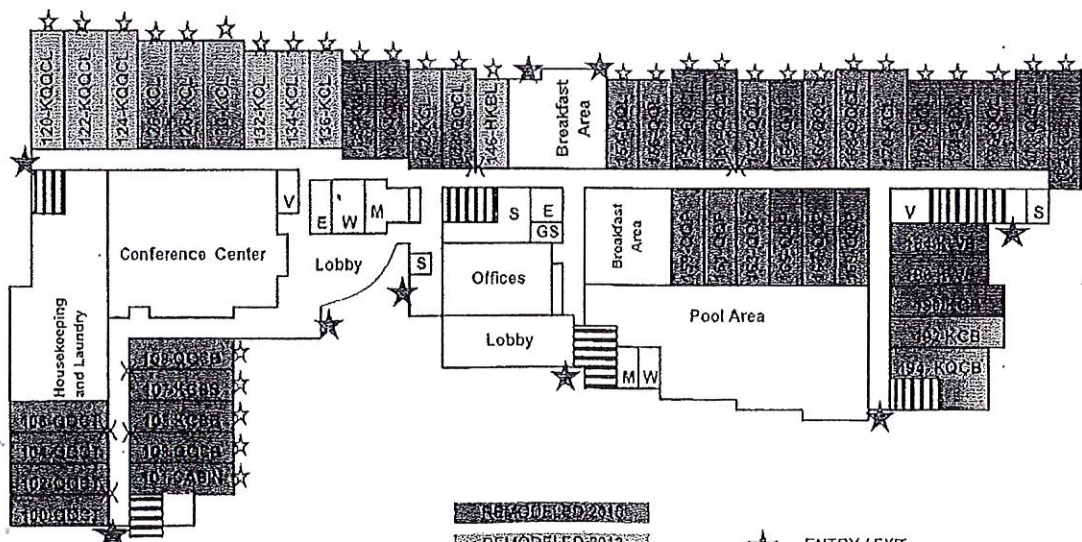
