Hello,

Thanks for meeting with the Planning and Development Division yesterday. We appreciate hearing about your project, regarding Safe Bay.

As discussed at the meeting, you will be applying for an Interim Use Permit for an Outdoor Living Site.

Please note that while City staff aim to identify potential items to be addressed and provide assistance in preparing applications, it is not possible to do a complete code review of your project at a pre-application

meeting. Additional permits or approvals may be identified as your project proceeds. In addition, many applications only address a certain portion of your project; staff review related to a certain application type does not constitute full review or implicit approval of the project as a whole.

All applications are submitted in the eplace portal: https://duluthmn.gov/eplace/.

After submitting your application, you will be notified of the staff person responsible for review of the application. You will be notified within 15 days whether the application is complete or incomplete. If incomplete, staff will identify additional information needed for your application. If complete, you will be notified of the Planning Commission date for your application, if applicable.

Planning Commission dates, along with associated deadlines, can be found at https://duluthmn.gov/boards-commissions/planning-commission/. Submitting by the deadline does not guarantee placement on a specific Planning Commission agenda; timelines are frequently altered by completeness of an application, number of items submitted in a specific month, etc. Occasionally items are tabled by Planning Commission. For these reasons, we strongly recommend you apply for all zoning approvals well in advance of submitting for building or other permits, to allow time for any unforeseen delays. Timelines shared by staff at pre-application meetings are approximate and not a guarantee of approval by any specific date. That being said, we can give a bit of an extension to the application deadline for your project. Please submit your application by the end of the week, 3/7, and we'll aim for getting the project on the April Planning Commission agenda.

Your project will need to meet all zoning requirements, which can be found at https://duluthmn.gov/planning-development/land-use-zoning-and-applications/zoning-regulations/. Some particular code areas you may wish to review include:

- Sec 50-20.1.I (page 16 of article 3) which identifies the standards for this use.

I followed up on a few items that I flagged during the meeting, see below.

- Screening- The adjacent woods will satisfy the screening requirement. Please note that this requirement will be reevaluated each year and additional screening may be required in the future.
- Signage- Operator information may be posted somewhere visible in the rear of the property, near where Safe Bay will be operating.
- Survey- The Land Use Supervisor has waived the requirement for a survey. When you submit your application, the platform will still require a survey. Please upload a copy of this email in place of the survey.


We also discussed that the City is required to send a mail notice to all property owners within 350 feet of the site. Has there been any outreach to neighbors regarding the project? If not, I suggest making some attempt to reach out to those folks so they are aware of what is being proposed. Let me know if you'd like assistance determining who to reach out to and I can give further direction.

Other City staff who attended this pre-application meeting are copied on this email. Feel free to reach out to any staff with questions on your project, or to keep us updated as your project proceeds. We look forward to working with you.


Hi Jason,
