3. Executive Board Elections

Guests introduce themselves to group

- Bylaws state COD must have 3 executive board members. Human Rights Officer Crawford will seek guidance from City Attorney, as many Commissioner terms are ending, with not enough members to fill open executive role positions.

 Positions may change as new commissioners are appointed to COD.

9b. Recruiting New Commissioners

- Applications are currently moving through the appointment queue.
 Will be reviewed by Mayor Reinert, then onto City Council for approval.
- Chair Crosby suggested sharing the COD tri-fold brochure to help recruit new commissioners. Human Rights Officer Crawford offered to review the brochure for any edits needed. Commissioner Berner offered to send brochure to local organizations.
- Human Rights Officer Crawford recommended holding a seat on the COD for a representative of the DTA. Chair Crosby will connect with DTA regarding this opportunity.

4. Current Disability Issues and Announcements

- CHUM interested in enhancing accessibility in their facility(ies).
 Commissioner Berner will connect John Cole with Center for Independent Living to assist.
- Commissioner Fochs shared concern over a friend's experience on the DTA. Discrepancy over whether the walker could be placed in an accessible seat and charged as a "second" occupied seat. Chair Crosby suggested the concerned passenger contact the DTA STRIDE advisory committee.
- Commissioner Berner updated COD on the Stepping On Up proposed housing project. The goal is to create transitional housing for those experiencing recent homelessness and help those individuals get re-established.

6. Parks and Rec Report

No Parks & Rec meeting in January.

- Potential growth of Spirit Valley Community Center, possible funding opportunity under Mayor Reinert's initiatives.
- Mr. Crawford mentioned a nearby community received three allterrain wheelchairs for accessible outdoor use.

5. Accessible Parking Update

- Approved by Parking Commission:
 - 530 N. 5th Ave E. St. Mark's Church, installed two zones
 - 230 E. Superior Street
 - 219 S. 60th Ave W.
 - 223 E. 6th Street
 - 15 N. 23td Ave W
- To review: 2717 W. 9th Street need site visit for recommendation

7. Skywalk Access Walk

Two groups met at Starbucks Superior St. and 4th Ave W. to experience Skywalk and look for accessibility opportunities.

- o Braille signage needed throughout
- Good lighting, good temperature
- Good gradients except for wooden bridge by Radisson
- o DECC & Pioneer Building gradient issue, not properly installed
- Amanda (Guest) agreed more opportunities for visually impaired. Braille is good but many indivdials with visual impairments don't read Braille. Suggested QR codes, an app, audio beacons - a modern solution to identify direction.
- COD will organize skywalk notes to 1) identify acute needs and priority fixes; 2) overall improvements, ideas and opportunities

8. Old Business

- "R" Word Update: Commissioner Castaldo meeting this week with ISD 709 coalition. Then, meeting planed with School Board Members Banks and Williams to discuss Hate and "R" word policies.
- Snow Removal Task Force: Chair Crosby invited commissioners to take MinneSNOWta Nice swag and pledge. Chair Crisby reached out to Mayor Reinert and new CAO to provide information about the campaign; concerns were expressed over language in the brochure. Chair Crosby affirmed to the COD that the current brochure was reviewed and approved under Mayor Larson, but that a new print was requested with revisions from the new City communications team.

 Chair Crosby also discussed the Snow Removal Task Force walk with City EAT (Equity Action Team). EAT participants given various impairments and walked neighborhood around 6th Avenue E. Was a great conversation and productive meeting.
