III. APPROVAL OF MINUTES

October 11, 2023

V. ELECTION OF OFFICERS

A. Election of President; *Commissioner Greene nominated Commissioner Stolee to serve a second year as Commission President. Commissioner Hobbs motioned to accept the nomination and was seconded by Commissioner Greene. The motion passed unanimously.*

B. Election of Vice President; *Commissioner Stolee nominated Commissioner Lafontaine to serve as Commission Vice President. Commissioner Hobbs motioned to accept the nomination and was seconded by Commissioner Greene. The motion passed unanimously.*

VI. DISCUSSION ITEMS

Taskforce-Recommended Revisions: The resolution creating the City of Duluth “Ordinance Modernization Taskforce” expired on December 31, 2023.

Accordingly, the taskforce has ceased to exist, but the question remains as to how (or if) the Charter Commission wishes to proceed with proposed changes.

Odd-Year Elections: The City of Duluth remains one of a handful of cities in the state that does not hold municipal elections alongside statewide elections every two years. The question has been posed whether the City should reconsider this system.

Charter Commission Membership: A perennial issue facing the City of Duluth is the challenge of recruiting members for City boards and commissions. The Charter Commission has been no exception and the question has been posed whether the size of the Commission should be reconsidered.
