WHEREAS, the parties desire to enter into this First Amendment to amend the Development
Agreement.
NOW, THEREFORE, in consideration of the mutual covenants and conditions hereinafter
contained, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend
the Development Agreement as follows:
1. That Paragraph A of Article I of the Development Agreement is hereby amended by
deleting the project assistance amount of "\$1,750,000" and by substituting the amount of
"\$2,750,000".
2. That Paragraph F of Article I of the Development Agreement is hereby amended by
deleting the eligible project costs amount of "\$12,222,477" and by substituting the
amount of "\$13,700,000".
3. That Paragraph H of Article I of the Development Agreement is hereby amended by
deleting total construction costs amount of "\$15,477,488" and by substituting the amount
of "\$17,494,359".
4. That Paragraph A of Article IV of the Development Agreement is hereby amended by

deleting the construction commencement date of "December 31, 2023" and by

substituting "June 30, 2024".

- 5. That Paragraph A of Article V of the Development Agreement is hereby amended by deleting the eligible reimbursement amount of "\$1,750,000" and by substituting the amount of "\$2,750,000".
- 6. That the Development Agreement is hereby amended by deleting Exhibit A and by substituting the Attached Exhibit A-1.
