**Old Business:**

**LAWFUL GAMBLING:**

**VETERANS OF FOREIGN WARS**– Application for Exempt Permit - Raffle at Post 137 VFW for November 11, 2018

Clerk Pirkola spoke on behalf of the application. This is an annual fundraising event at the VFW A motion to approve was made by Commissioner Rosenthal, and a second was made by Commissioner Hanson and it was unanimously approved.

**NEW BUSINESS:**

**RED BAMBOO, LLC (DBA THAI BY THAI)** \_ Application for the transfer of the on sale 3.2 malt liquor license for the period ending April 30, 2018 and on sale wine license period ending August 31, 2019 from Loy Krathong, Inc. (dba Sala Thai) to Red Bamboo, LLC (dba Thai by Thai) Mr. Abrahamson appeared on behalf of the application and explained that there would be no changes to the business, except the name. Commissioner Stauber made a motion to approve the transfer, and a second was made by Commissioner Hanson for both licenses. Motion carried.

**LAKESIDE LIQUORS INC.** - Application for the issuance of an off sale intoxicating liquor license for the period ending August 31, 2019, from Dawn and Mark Moran, Lakeside Liquors, INC. (dba Lakeside Liquors), 4507 East Superior Street, With Dawn Moran 51% owner and Mark Moran 49% owner. Both owners appeared on behalf of the application. Dawn told the commissioners that they planned on being open 7 days a week from 9:00 a.m. - 10:00 p.m. and Sunday's from 11:00 a.m. - 6:00 p.m. The Clerk Pirkola explained that there are currently 7 licenses still unused, and that the location was in the correctly zoned area. A motion to approve the application was made by Commissioner Rosenthal, and a second was made by Commissioner Hanson. Motion carried.

**DM STOKKE, INC.** - Application for the issuance of an off sale intoxicating liquor license for the period ending August 31, 2019, from Shane Stokke, DM Stokke Inc. (dba Stokke's Liquor Store) 5631 East Superior Street, with Monica Regina Stokke 50% owner and Dennis William Stokke 50% owner. Shane Stokke appeared on behalf of the application. Mr. Stokke explained that they too would be open 7 days a week, but would evaluate sales after a few months to determine permanent hours. A motion to approve was made by Commissioner Rosenthal and a second was made by Commissioner Stauber. Motion carried.
