

Hello Laura,

Thank you for the information you provided below in your last two emails.

I guess what I was trying to figure out is how the rate was established? I see that there is at least \$4.6M that needs to be invested annually in stormwater-related capital projects in order to fund the existing infrastructure, but what other debt service/operating/maintenance costs were included in the development of the fees? Who analyzed the costs and developed the rate structure? In 2023 it looks like there was a surplus of funds of around \$3 Million in revenues collected, vs expenses paid and only 1.2M of construction/capital costs. I'm just curious of who puts together the projections to see if I could just talk with them about it. If that person is you, then I'm happy to chat with you.

Good morning, Joelle,

Apologies, for the delayed response. Below and attached are my findings regarding the rate structure for July 2021 to July 2026.

- 1. See attached the Storm Rate History from 09/01/1998 to 07/01/2026.
- 2. See attached Duluth Public Utilities Commission (PUC) Meeting Minutes 08-18-2020. The PUC approved (resolution 20PUC-002) the 6-year rate structure from January 2021 to January 2026 but was amended to reflect July 2021 to July 2026. The *Findings of Fact* and *Statement of Purpose* can be found on attached Resolution No. 20PUC-0002 (20PUC-002 Stormwater 6-year Rate Increase Amended).
- 3. The Commission first evidenced its intent to consider storm rate structure plan when it passed Resolution No. 20PUC-001 on March 17, 2020, and called for public input. The Commission held a public meeting on July 21, 2020, at which the public was invited to provide comments on the proposed new rate structure. If you want to review further PUC meeting agendas or minutes for March 17, 2020 and July 21, 2020, you find access on the Duluth Public Utilities Commission here.

The ERU value is determined by the total square footage of impervious surface on the nonresidential property **divided** by the average impervious surface area in Duluth for a single-family dwelling. The average impervious surface area for a single-family dwelling in Duluth is currently 2,228 sq ft.

Hello Laura,

You were planning to send over the expected costs per ERU increases over the next several years. City Code gives authority to the PUC to set the fee. Code also states how that should be calculated.

• The fee should be cost recover of the capital costs, debt service and operation and maintenance costs of the stormwater facilities in the city.

 The Duluth public utilities commission shall, by resolution, adopt a schedule of utility fees sufficient to produce revenue equal to the budget of the stormwater utility. The resolution shall state the utility fee rate per ERU;

I'm curious if you know who puts together the cost structure of the ERU and rate, or if I could talk to them?

I also noticed that there is a Utility Fee Adjustment section which allows for a person to request an adjustment if the stormwater runoff from the property never enters any facility of the stormwater drainage system. (Sec. 43-67. Utility Fee adjustments) I'm wondering if this would apply to the properties at DLH (Duluth International Airport) on the north side of the runway which flows north - off airport property and outside the City of Duluth and their stormwater systems. Could this also apply to DYT (Sky harbor Airport)?

I'm putting together my request for more information/clarification from Kaplan & Kirsch, which is what led me down this path.

RESOLUTION NO. 20PUC-002

RESOLUTION ESTABLISHING USER CHARGES FOR THE CITY'S STORMWATER UTILITY EFFECTIVE AS OF JULY 1, 2021; SUPERSEDING ALL PRIOR INCONSISTENT OR CONFLICTING RATES.

RESOLVED by the Duluth Public Utilities Commission (the "Commission") that the Commission hereby makes the following Findings of Fact:

- 1.) The City has historically incurred capital costs, debt service costs, operating and maintenance costs for the creation and maintenance of a stormwater utility system which benefits all properties and property owners in the City and continues to incur these costs on an ongoing basis.
- 2.) Pursuant to Chapter 43 of the Code, the City has established a stormwater utility for the purpose of constructing, operating, and maintaining the City's storm sewer system and has provided for a stormwater utility charge to fund the expenses thereof.
- 3.) At least \$4.6 Million needs to be invested annually in stormwater-related capital projects in order to fund replacement of existing infrastructure as needed and to meet changing load conditions brought on by development, climate change, and other factors.
 - 4.) The City has not increased its stormwater utility fees since January 1, 2016.
- 5.) It is necessary and reasonable to increase the stormwater utility fees as provided for below to fund the increased costs to the City's stormwater utility and necessary improvements thereto.

FURTHER RESOLVED, that pursuant to Section 43-66 of the Duluth City Code, 1959, as amended, for the purpose of increasing the revenue of the stormwater utility, there is established a user charge as provided in said ordinance effective July 1, 2021. The user charge rate shall be based upon equivalent residential units (ERU = 1,708 impervious square feet) per month, as follows:

STATEMENT OF PURPOSE

This resolution adopts a stormwater rate increase of approximately 11.25% per year for each of the next six years. This increase will raise the total funds available for capital projects to an estimated \$4,600,000 in year 2026. As found by the Commission, this represents the minimum investment necessary in the City's stormwater infrastructure to prevent further deterioration of the system and to maintain its viability to serve the needs of the system's users.

The Commission first evidenced its intent to consider this plan when it passed Resolution No. 20PUC-001 on March 17, 2020, and called for public input. Subsequently, the Commission held a public meeting on July 21, 2020, at which the public was invited to provide comments on the proposed new rate structure. In addition, the Director of Public Works and Utilities and staff, along with Commission members, met with the Chamber of Commerce to seek further input on the needs of the system and the proposal to address those needs.

After receiving all of the input provided and weighing what has to be done to preserve the system, staff brought forth this resolution adopting the plan for the Commission's approval after a formal hearing before the Commission as required by its Bylaws.

This resolution sets stormwater rates effective July 1, 2021.

NOTICE OF PUBLIC HEARING: The Duluth Public Utilities Commission will hold a public hearing by electronic means regarding proposed stormwater rate increases to fund the capital costs of improvements to the City's storm sewer system on Tuesday, August 18, 2020 at 5:15 p.m. The purpose of this public hearing will be to discuss the current state of the stormwater utility, to explain the proposed changes to the stormwater rates, and to receive comments from the public regarding the proposed changes.

THE HEARING: The public hearing will be held at the commencement of the regular Commission meeting, which will be held by "other electronic means" pursuant to Minnesota Statutes Section 13D.021 in response to the COVID-19 emergency. Some members of the Board will be participating through video conference.

PUBLIC PARTICIPATION/PUBLIC COMMENT: Due to the COVID-19 emergency and the limitation on the use of City facilities, the hearing and regular meeting will be in a virtual, electronic format and not in a personal, public format, and public comment will not be taken in person. STORMWATER RATE INCREASE PUBLIC HEARING

The Commission held a public hearing regarding proposed stormwater rate increases at the commencement of the regular meeting. Tom Johnson, Senior Engineer for the City, gave a presentation on the stormwater utility. President Ryan read an email that had been received from David Ross, President of the Duluth Area Chamber of Commerce, proposing a one-year delay in the rate increases. Councilor Roz Randorf, 901 West First Street, asked about how the rate increase would affect commercial and industrial customers. Councilor

Terese Tomanek asked about rate increases for residential customers, which customers would be affected most by the increases, and how a delay would impact the City budget. The public hearing concluded at 5:47 p.m.

PUBLIC COMMENT PERIOD

No citizens had comments at this time.

Commissioner Sipress motioned to approve the minutes, and the motion was approved unanimously.

UNFINISHED BUSINESS

Stormwater system discussion

Tom Johnson talked about the need for stormwater program documentation as more customers may be interested in credits for Best Management Practices (BMPs). He also mentioned a need for further definition of waterfront properties requirements. There was some discussion about whether the BMP credits resolution should be done at the same time as the stormwater rate resolution and whether implementation of the stormwater rate increases should be delayed. Commissioner Anderson proposed a six-month delay in implementation of the rate increases as a compromise. Commissioners agreed that the rate increase implementation could be delayed six months, but that there was no need to delay a vote on the resolution. There was further discussion of staffing and resources needed to manage the stormwater program.
