

**FIRST AMENDMENT TO THE AGREEMENT FOR SERVICES  
BETWEEN ST. LOUIS COUNTY AND THE CITY OF DULUTH  
FOR FY 2018 OPERATION STONEGARDEN**

THIS FIRST AMENDMENT TO AGREEMENT is by and between the CITY OF DULUTH, a municipal corporation under the laws of the State of Minnesota, hereinafter referred to as "City", and ST. LOUIS COUNTY, a Minnesota county acting through its governing body, hereinafter referred to as "County".

WHEREAS, the County is the recipient of a grant from the U.S. Department of Public Safety, Homeland Security and Emergency Management Division, Bureau of Customs and Border Protection, the terms of which are set forth in Operations Order OPSG FRAGO MN-St. Louis, FY 18, Number 19 GFNDUM-11-001 Version 1 (hereafter "Grant"), pursuant to which County is to act as fiscal agent for Operation Stonegarden, an operational plan designed to augment enforcement operations within the Duluth Border Patrol Station Area of Responsibility (hereinafter "Duluth AOR");

WHEREAS, the parties hereto did enter into an agreement memorializing the parties' rights and responsibilities in the implementation of said Grant, which agreement is dated December 2, 2019 and bears City Contract No 23803. hereinafter referred to as "Agreement";

WHEREAS, the U.S. Department of Public Safety, Homeland Security and Emergency Management Division, Bureau of Customs and Border Protection, has awarded the County a Supplemental Grant to provide increased presence of law enforcement personnel within the Duluth AOR;

WHEREAS, the parties hereto desire to amend the Agreement as stated below; and

THEREFORE, the parties agree as follows:

In this Agreement deleted terms will be struck out and the added terms will be underlined.

AMENDMENT 1. That ARTICLE II, Reimbursement for Services, is amended as follows:

A. Reimbursement for Services

County hereby agrees to reimburse City for "Eligible Costs" incurred by it in the performance of the work under the terms and conditions of this Agreement in an amount not to exceed ~~\$44,035~~ \$49,114. For the purposes of this Agreement, "Eligible Costs" shall mean the costs incurred by City for operational overtime and fringe benefits paid to or on behalf of employees providing services relating to the work provided hereunder at the rates set forth in Exhibit A. Requests for reimbursement shall be made no more frequently than monthly and shall be accompanied by such documentation as County shall reasonably request. Upon receipt of said request and the appropriate documentation, County shall promptly reimburse City for the "Eligible Costs" up to the amount set forth in Exhibit A.

Except as amended herein, the terms and conditions of the Agreement and all previous amendments shall remain in full force and effect.
