DULUTH LEGISLATIVE CODE.

CHAPTER 8.

BEVERAGES.

Article 1. Alcoholic Beverages.

Subdivision II. Licenses.

Sec. 8-44. To whom licenses issued--intoxicating liquor.

- ...(e) Temporary on sale liquor licenses shall be issued only to:
- (1) Clubs, charitable organizations, religious organizations and other nonprofit organizations in existence for at least three years;
 - (2) A registered political committee;
 - (3) A state university; or

of a full-year on sale intoxicating liquor license used by the city;...

(4) A brewer who manufactures fewer than 3,500 barrels of malt liquor in a year; in connection with a social event sponsored by the licensee. The license shall be issued for a limited length of time, not to exceed four consecutive days. Temporary on sale licenses to any one organization or for one location shall not exceed more than three four-day, four three-day, six two-day or 12 one-day licenses, in any combination not to exceed 12 days per year. No more than one license shall be issued to any one organization or for any one location within any 30 day period unless the licenses are issued in connection with an event officially designated a community festival by the city. The city may authorize the temporary on sale liquor license on premises other than premises the licensee owns or permanently occupies. The license may provide that the licensee may contract for intoxicating liquor catering services with the holder
