U.S. Department of Justice Grant

Reimbursement is also available for participating jurisdictions through a federal grant award from the United States Department of Justice Office of Justice Programs. Applications for federal bullet-proof vest (BVP) funds must be submitted during an annual 6-week open application period. Federal funding decisions are made after the close of the application period. Applicants will then be notified via email regarding approved funding levels. Funding will not be received until the vests are purchased at which time the jurisdiction can submit a request for reimbursement through the Federal BVP website.

Minnesota State Patrol

If you are a Minnesota State Trooper, you do not need to inquire into the federal program for reimbursement as the Minnesota State Patrol is part of the Minnesota Department of Public Safety and as your employer, the Minnesota State Patrol will contribute towards the employer portion.

Reimbursement Amounts

- For vests purchased on or after October 1, 2015, the maximum reimbursement amount is \$737.42. (The reimbursement amount changes every October 1 based on the Consumer Price Index.)
- For vests purchased on or after October 1, 2014, the maximum reimbursement amount is \$736.68.
- For vests purchased on or after October 1, 2013, the maximum reimbursement amount is \$721.53.
- For vests purchased on or after October 1, 2012, the maximum reimbursement amount is \$708.77.
- For vests purchased on or after October 1, 2011, the maximum reimbursement amount is \$696.92.
- For vests purchased on or after October 1, 2010, the maximum reimbursement amount is \$672.70.
- For vests purchased on or after October 1, 2009, the maximum reimbursement amount is \$665.38. (The annual percentage change in the Consumer Price Index from June 2008 to June 2009 was 1.4%.)
- For vests purchased on or after October 1, 2008, the maximum reimbursement amount is \$674.83.
- For vests purchased on or after October 1, 2007, the maximum reimbursement amount is \$642.70.
- For vests purchased on or after October 1, 2006, the maximum reimbursement amount is \$625.80.
- For vests purchased on or after June 3, 2005, the maximum reimbursement amount is \$600.00.
- For vests purchased before June 3, 2005, the maximum reimbursement amount is \$360.87.
