1.0 Project Scope

The TRC Team has prepared design plans and specifications for the outfall site and performed construction observations. Unexpected highly fractured bedrock resulted in changing the design from rebar anchors to micro-piles; this also increased the construction timeframe, contractor's means and methods, and our construction administration efforts.

Scope of Work

1. Bottom of Bin Wall & Bedrock Excavation Inspections

Additional site visits were required to investigate the Contractor's work, the bedrock conditions, and the attempted rock drilling techniques. The bedrock was found to be highly fractured and less competent than anticipated.

2. Additional Design Work

As a result of the weak and fractured bedrock encountered, our project team performed a new analysis and created additional design details for the installation of micro-piles to serve as the new bedrock anchors. We worked closely with the Contractor to produce constructible designs utilizing the Contractor's equipment available.

3. Reviewing Change Orders and Producing Engineering Proposal Requests

We have issued several engineering proposal requests and reviewed multiple iterations of change orders from the Contractor. We have negotiated all change orders on behalf of the City to ensure fair change order pricing.

4. Remaining Construction Administration Services

We will complete the remainder of construction administration services for this project, which will include meetings, RFIs, ESIs, Change Orders, Pay Applications, Site Inspections, and Final Walkthrough and Punchlist. We have included four additional site visits, two contractor pay applications, and one Change Order. As-built plans are not included in our scope.

2.0 Fees

Our team will complete all services described in this proposal for a lump sum cost of **\$17,339.00**, including all direct work and associated expenses. The TRC team will complete the work on a Lump Sum (LSUM) basis, in accordance with our approved Standard Terms and Conditions Agreement. The budgets identified in the table above will not be exceeded without CLIENT approval.
