Kerry Venier stated that staff budgeted enough to cover the increase. WLSSD should be with us next month to explain their budget process and operations.

UPDATES FROM STAFF

Howie Smith reported on projects including the water main going through the Northland Country Club, design for next years' projects, Woodland Booster Station, and stormwater tunnel repair. Cyndi Falconer reported that the Lincoln Park project is wrapped up for the year. The high priority lead replacement project is very active. Many will be postponed until next spring. We are working on projects for 2025. Lead Copper Rule Compliance starts tomorrow. About 14,000 letters will be sent out. The website has been updated. The City is planning to do about 1,700 lead service replacements next year.

COMMISSIONER QUESTIONS OR COMMENTS

Commissioner Crouse asked about the sewage leak into Chester. Howie Smith responded that the segment of pipe was repaired and will be lined with cured in place pipe.

UPCOMING COUNCIL ACTIONS

No actions were mentioned.

The next regular meeting is scheduled for Tuesday, November 19, 2024 at 5:15 p.m. in City Council Chambers. WLSSD representatives will attend the November meeting to explain their 2025 budget. The Commission will continue discussing options for the water infrastructure surcharge.
