Hello Councilors,

I am writing to strongly urge you to reopen Safe Bay while the complaint against it is being investigated. I don't want to speculate about the complaint or minimize it if it is actually serious, and I think the city is perfectly within reason to fully investigate it. But I don't think it's appropriate to immediately and completely shut it down before any investigation has taken place. This site has not had any issues before to my knowledge and it's a necessary resource for some of the most disadvantaged members of our community. Closing Safe Bay down sends the message that the city is willing to punish the entire group of people that use the site based on a single complaint that hasn't even been corroborated, and that in the future if a neighbor wants to get rid of the homeless people, all they have to do is make a false complaint and the city will shut it down for them. By all means investigate the complaint, but please don't stop people from going there until you have an actual reason to do so.

Good Morning Council Members!

I wanted to send you an email in advance of the meeting scheduled for this Thursday to share my thoughts on the appeal that was filed regarding the permit for Safe Bay operations.

I am a member of the Vineyard church and became aware of Safe Bay when the church offered our space for Safe Bay guests to use. I wasn't familiar with it but it sounded like a good option so I attended the volunteer training. I have completed one volunteer shift and am scheduled to do more this month!

In the one time that I volunteered I learned a lot about the program and observed that the guests were very compliant with rules/expectations, were very quiet and were very thankful for a quiet peaceful place to park and sleep for the evening. They were also grateful for the clean bathroom and shower facilities. Some of the guests checked in and then immediately parked, tucked themselves in for the evening and I never heard from them again. Others came in for showers or coffee and some stopped to chat. I got to hear stories of a variety of situations and learned that they were at varying places in their journey to find permanent housing. One had a full time job and fell on hard times and lost his housing. Two had interviews the following day for possible apartments. One had an appointment with the Human Development Center to look at housing options. The thing they all had in common was a need for a place to get a good night's sleep in the meantime.

Not one of the people did one thing to cause a disruption to the neighbors or anyone around them. And on the hourly required "rounds" of the perimeter that the staff/volunteers do to pick up trash, no trash was found while I was there. I see more trash in my own neighborhood when I walk my dog!!

What I did hear was that despite the fact that it got cold that night and the staff and volunteers were wearing coats and thankful for a heated building, the guests weren't allowed to leave their cars running so they could have heat. Because a neighbor complained. And I heard every car that pulled in that evening and not one of them was a loud vehicle.

Another thing I heard was a report that a guest made to staff that the night before she and her significant other had gotten very poor rest because neighbors from the houses behind the church came up to their vehicles and shined lights in the windows, disturbing the guests and causing the guests' dogs to bark.

I also heard a report that a previous night, neighbors had lined up chairs and sat and watched the guests as they arrived, parked, got settled, and slept in their vehicles. And while people can do what they want on their own property it certainly gives the impression that they were trying to send a message that the Safe Bay guests were not welcome.

I did not witness these events myself but heard about them from various guests and staff.

I was really sad and frustrated to hear that these folks were essentially being harrassed while

doing nothing wrong and while participating in an approved activity and complying with all expectations.

I asked some staff members how neighborhood complaints were being handled and was told that CHUM is trying to do everything they can to maintain a peaceful relationship with the neighborhood and was complying with their requests even when they didn't need to or when it was a detriment to the program.

CHUM is clearly doing everything that is required of them to be allowed to operate this program at the Vineyard Church.

My biggest takeaway from the night that I was there was how much I enjoyed meeting some new people and hearing their stories. I left feeling proud to be a member of the Vineyard that was opening up this space for these folks and wondering what I could do to assist in providing needed supplies and other resources.

I left feeling very impressed by the program and how smoothly and effectively it was run and how such a simple thing could meet a basic practical need for numerous people.

I really hope that you as a council will look at the whole picture and see what a fantastic program this is and what a service it provides to our community members. I understand that sometimes fear of the unknown can make people act in ways that are not helpful or respectful and I'm hopeful that in time the neighbor that is voicing these concerns will see that this program is a benefit to our community and a way for us to all work together to help each other.

Respectfully, I am asking that you reject the appeal and allow the permit to stand and the Safe Bay program to continue operating on the Vineyard Church property.
