**BACKGROUND:** Enger Park Golf Course had critical infrastructure that was failing and needed to be replaced to support successful golf operations. Major items recommended in the renovation plan include:

- 1) New 27-hole irrigation system including HDPE pipe, sprinkler heads, wire and central control.
- 2) New pump station.
- 3) Expanded irrigation pond and transfer pipes.
- 4) Upgraded City water supply line and meter.
- 5) Leveling and regrassing of specific fairways to improve drainage and playability.
- 6) New course signage.
- 7) Expanded driving range tee with synthetic tee-line and new irrigation.
- 8) Driving range with target greens and chain-link fence at the end of the range.

The planning process included a team of four industry professional consultants, three public engagement sessions, four Parks and Recreation Commission Public Golf Committee meetings, an online survey, and an

open house at Enger Clubhouse including comment cards. The Parks and Recreation Commission's Public Golf Committee unanimously recommended the plan at their September 8, 2021 meeting. The Parks and Recreation Commission unanimously recommended the plan at their September 15, 2021 meeting.

**BUDGET/FISCAL IMPACT:** Increase the contract by \$10,161.09, for a new contract total not to exceed \$126,991.09 from Golf, Parks and Recreation, Enger Renovation, Improvements Other than Buildings, Enger Golf Course Renovation, Enger Golf Course Renovation Phase 1

**OPTIONS:** Approve the resolution and the project will be able to be closed out. If denied the project will be halted.
