

The undersigned City of Duluth, a Minnesota Municipal Corporation hereinafter called the "City," hereby grants to the UNITED STATES OF AMERICA, hereinafter called the "Government," a right-of-entry agreement upon the following terms and conditions:

- 1. The City hereby grants to the Government, its agents, and assigns an irrevocable right to enter upon the lands hereinafter described at any time from the date of signature through December 31, 2024, in order to perform construction work of any nature in conjunction with tying the Government's shoreline protection structure into the City's existing walkway, including the repositioning of existing stonework, lakeward of the structure.
- 2. The land affected by this right-of-entry agreement is located in the County of St Louis, State of Minnesota, and is described as follows: 504 Canal Park Duluth, MN, PIN: 010-4370-00070, an as depicted on "Exhibit A", outlined in yellow, which is attached hereto and incorporated by reference into this Agreement. (Hereinafter the "Land").
- 3. This right-of-entry agreement includes the right of Government, its agents, and assigns, ingress and egress on other lands of the Owner not described below, provided that such ingress and egress is necessary and not otherwise conveniently available to the Government, excepting the public parking lot.
- 4. Storage of all tools, equipment, buildings, improvements, and other property taken upon or placed upon the land by the Government shall remain he property of the Government and shall be removed at the expiration of this right to entry. City shall not be responsible for any damage caused by third parties to tools, equipment, buildings, improvements, and other property taken upon or placed upon the Land by the Government.
- 5. If any action of the Government's employees or agents in the exercise of this right-of-entry agreement results in damage to the real or personal property, the Government will repair or replace said property to its condition prior to execution of this right-of-entry agreement. The Government's liability under this clause may not exceed appropriations available for such payment and nothing contained in this agreement may be considered as implying that Congress will, at a later date, appropriate funds sufficient to meet deficiencies. The Government's liability for damages, claims, suits, costs, and expenses that arise from, or are due to the activities of the Government tortious acts or omissions of federal officers or employees under this Right of Entry shall be governed by the Federal Tort Claims Act, 28 USC 1346©, and other applicable federal laws.
