That as of the execution of this Termination Agreement by both parties, the Development Agreement shall be terminated and of no further force and effect and, except as set forth in this Termination Agreement, neither party shall have any further rights hereunder nor any further obligations to the other party thereunder.
- 2. That upon execution of this Termination Agreement, Developer shall cause this Termination Agreement to be recorded in the office of the County Recorder for St. Louis County Minnesota and, upon the successful recording thereof, shall cause a fully executed copy thereof with recording information affixed thereto to be provided to the City at the address provided for

Notifications in Article VIII of the Development Agreement.
