

**NOTICE OF FUNDING RESTRICTIONS**

This NOTICE OF FUNDING RESTRICTIONS is made this \_\_\_\_ day of \_\_\_\_\_, 2026, by the City of Duluth, a Minnesota municipal corporation (“City”).

WHEREAS, City is the owner of certain real property located in the State of Minnesota, County of St. Louis, legally described on the attached Exhibit A (the “Property”); and

WHEREAS, City has entered into Conservation Partners Legacy Grant Program Grant Contract No. 198402 with the State of Minnesota, acting through its Commissioner of Natural Resources (“State”) for a project entitled “City of Duluth/Knowlton Creek Acquisition and Restoration” (the “Grant Agreement”); and

WHEREAS, as a requirement of the Grant Agreement and in accordance with Minn. Stat. § 97A.056, subd. 15 and Minnesota Laws 2020, Regular Session, Chapter 104, Article 1, Section 2, Subd. 5(r), City is required to record this notice of funding restrictions on the Property.

NOW, THEREFORE, in order to comply with the Grant Agreement, the City does hereby state the following:

City’s interest in the Property shall be administered in accordance with the terms, conditions, and purposes of the Grant Agreement controlling the acquisition of the Property. City’s interest in the Property, or any portion of the interest in the Property, shall not be sold, transferred, pledged, or otherwise disposed of or further encumbered without obtaining the prior written approval of the Lessard-Sams Outdoor Heritage Council or its successor. The ownership of the Property transfers to the State if: (1) the holder of the interest in real property fails to comply with the terms and conditions of the Grant Agreement or accomplishment plan; or (2) restrictions are placed on the land that preclude its use for the intended purpose as specified in the appropriation.

This Notice of Funding Restrictions shall run with the land.

## LINE "B"

COMMENCING AT A POINT ON THE EAST AND WEST QUARTER LINE OF SAID SECTION 1 DISTANT 503.04 FEET EAST FROM THE WEST QUARTER CORNER OF SAID SECTION 1; THENCE AT A DEFLECTION OF 41 DEGREES 19 MINUTES 30 SECONDS TO THE NORTH, A DISTANCE OF 480.00 FEET TO THE POINT OF BEGINNING OF LINE "B" TO BE DESCRIBED; THENCE AT A DEFLECTION OF 90 DEGREES 00 MINUTES 00 SECONDS TO THE RIGHT A DISTANCE OF 422.06 FEET TO THE SOUTH LINE OF SAID SW 1/4 OF NW 1/4 AND SAID LINE "B" THERE TERMINATING.

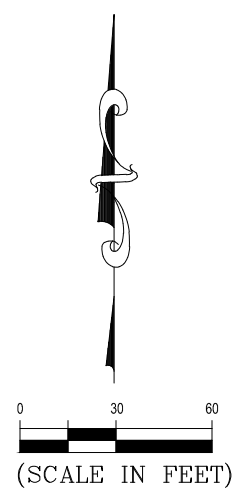
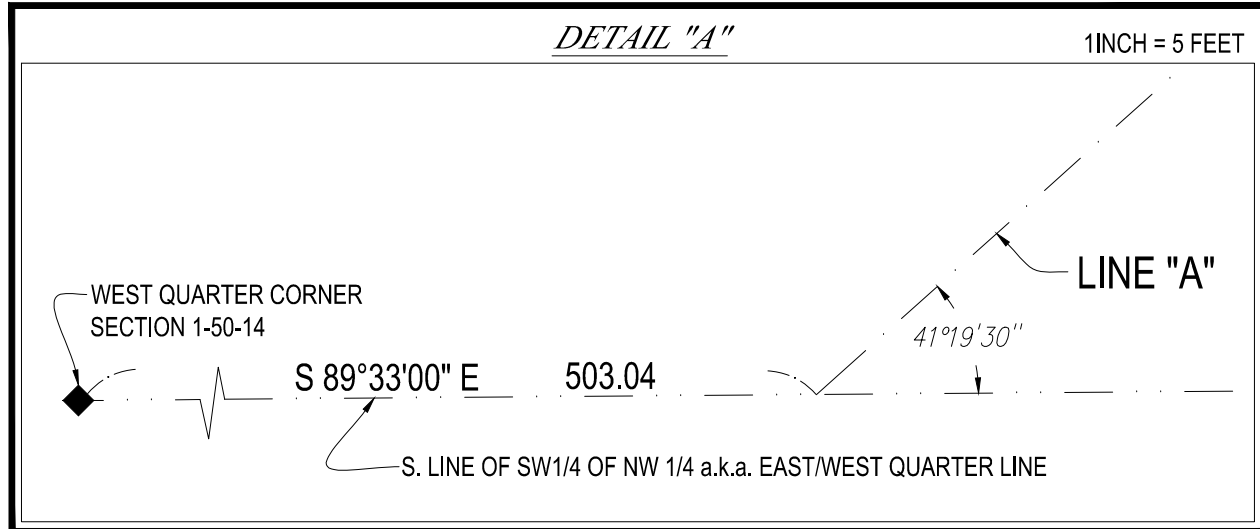
