# FIRST AMENDMENT TO AGREEMENT BETWEEN THE CITY OF DULUTH, CENTER FOR ALCOHOL AND DRUG TREATMENT, AND JEFFREY R. MAAHS, PHD. FOR THE FY 2020 COMPREHENSIVE OPIOID STIMULANT AND SUBSTANCE ABUSE PROGRAM (COSSAP) AWARD

THIS FIRST AMENDMENT is made and entered into by and between the CITY OF DULUTH, a municipal corporation of the County of St. Louis, State of Minnesota, hereinafter referred to as "City", and the CENTER FOR ALCOHOL AND DRUG TREATMENT, a private nonprofit corporation under the laws of the state of Minnesota, hereinafter referred to as "CADT".

WHEREAS, the City is the recipient of an Office of Justice Programs Award from the U.S. Department of Justice, pursuant to which the City is to act as fiscal agent for funds to be used for the operation of the City of Duluth FY 2020 Comprehensive Opioid Stimulant and Substance Abuse Program (COSSAP), as more fully set forth in an Agreement with CADT dated January 11, 2021 and identified as City Contract #24057 (the "Agreement"); and

WHEREAS, CADT has requested clarification of the reimbursable fees and costs allowed under the terms of the grant award; and

WHEREAS, the City is willing to identify in more detail the reimbursable fees and costs CADT is allowed to charge under the terms of the grant award; and

WHEREAS, the City and CADT are willing to amend the Agreement as stated below.

THEREFORE, the City and the CADT agree as follows:

In this Amendment to Agreement, the deleted terms will be struck out and the added terms will be underlined.

**AMENDMENT 1**. Article II-Fees shall be amended as follows:

### **ARTICLE II**

### Fees

It is agreed between the parties that CADT shall be paid the sum of Ninety-eight Thousand Six Hundred Fifty Dollars (\$98,650.00) per year for the provision of the full-time LADC. CADT's fees <u>and costs</u> for each year of the award shall not exceed \$98,650.00. <u>Reimbursable fees and costs include the following:</u>

Salaries

Benefits

Reasonable Administrative Costs

In no event shall the total annual fees and costs exceed the sum of \$98,650.00.

# **AMENDMENT 2.** Article III – Term of Agreement shall be amended as follows:

### ARTICLE III

## Term of Agreement

Notwithstanding the date of execution, the term of this Agreement shall commence on October 1, 2020 and terminate on September 30, 2023. <u>Notwithstanding the date of execution, the term of this First Amendment shall commence on January 1, 2022.</u>

Except as amended herein, the terms and conditions of the Agreement and all previous amendments remain in full force and effect.
