## EASEMENT AGREEMENT

### WITNESSETH:

Whereas, Grantor is the owner of the property in St. Louis County, Minnesota legally described as follows (the AProperty@):

All that part of the South Half of the Southeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 7, Township 50 North, Range 13 West lying between two lines parallel with the Northerly most boundary line thereof and 75 feet and 145 feet, respectively Southerly therefrom and between the Easterly line thereof and a line parallel therewith and 237 feet westerly therefrom.

Whereas, Grantor wishes to convey to the Grantee an easement as hereinafter described for drainage purposes over the Property for the benefit of the Property and at no cost to Grantee.

NOW THEREFORE, in consideration of One (\$1.00) Dollar and other good and valuable consideration, receipt of which is hereby acknowledged, Grantor does grant, sell, bargain and convey to Grantee in trust for the general public a permanent, perpetual and exclusive easement for \_\_\_\_\_ drainage purposes over the Property, the location of which easement is more particularly described as follows:

All that part of the South Half of the Southeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 7, Township 50 North, Range 13 West of the 3rd Principal Meridian, lying between two lines parallel with the North boundary line thereof and 75 feet and 95 feet respectively southerly therefrom and between the East line thereof and a line parallel therewith and 130 feet westerly thereof.
