

**MINUTES OF THE REGULAR MEETING OF THE

**COMMUNICATIONS:**

January Meeting Minutes – Motion made to approve by Commissioner Stolee, second made by Commissioner Rosenthal. Motion carried.

**LAWFUL GAMBLING:**

**Ducks Unlimited, Inc. raffle exemption – 60 day waiver**

Andrew Onken was present on behalf of Ducks Unlimited, Inc. Ryan Stauber asked how many years they had been conducting this raffle and banquet. Mr. Onken stated that this would be their 3<sup>rd</sup>. A Motion to approve the permit was made by Commissioner Rosenthal and a second was made by Commissioner Hanson. The application was unanimously approved

**Regents of the University of Minnesota, raffle exemption – 60 day waiver.**

No one was present on behalf of the permit request. Item was tabled to the end of the meeting. No one showed up by the end of the meeting. Clerk Bobbi Pirkola stated that they would be giving away hockey tickets at Clyde Iron on Thursday, February 23. Kira Bremer was present on behalf of the Coalition. Ms. Bremer explained the raffle would be held at Clyde Iron Works and all funds would go towards the Quarry Park Winter Event. This is their second year to hold the event. A motion was made Commissioner Wisocki and a second was made by Commissioner Stauber. Motion carried.

**CP DULUTH, INC (CROOKED PINT ALE HOUSE) 1402 W ARROWHEAD ROAD-**  
APPLICATION FOR AN ON-SALE INTOXICATING LIQUOR LICENSE, AND SUNDAY  
SALE LICENSE, RUSS SMITH 27.5%, KIM BAILEY 17.5%, JINELL ABERNETHY

17.5%, DARL GOSSELINE 12.5%, JEFF AMRAEN 12.5%, JOSH AND NICHOLE WIDDES 12.5%, FOR THE PERIOD ENDING AUGUST 31, 2017. Mr. Russ Smith present on behalf of the application. Mr. Smith explained that this would be part of a franchise under the same umbrella as Green Mill. They plan on opening early May. There will be seating for 200 people inside and seating 70 on the patio. The restaurant is located on the corner of Kenwood and Arrowhead. A motion was made by President Wisocki and a second was made by Commissioner Stauber. Motion carried.

Mr. Halvorson was present on behalf of the application. Mr. Halvorson explained that this Pizza Hut would comply with liquor training for all employees. This Pizza Hut will be identical to the one on Woodland Ave without patio seating. The commission requested the application be updated with the local manager on it. A motion to approve was made by Patricia Stolee contingent on the addition of the new manager revised on the application and a second was made by Commission Osthus. Motion carried.

APPLICATION FOR A TEMPORARY ON SALE INTOXICATING LIQUOR LICENSE FOR SEPTEMBER 15-16, 2017 WITH RYAN KERN, MANAGER. Jean Stoivich was present on behalf of the application. Ms. Stoivich explained that this is the 4th year for the event. Motion was made by Commissioner Stolee, and a second was made by Commissioner Stauber. Motion carried.

There were no questions for Ms. Stoivich and she explained that this would be the 12<sup>th</sup> year for the races. A motion was made by Commissioner Stauber and a second was made by Commissioner Rosenthal. Motion carried.
