DISCUSSION ON THE CHARTER COMMISSIONS INTENTIONS ABOUT MEETING, IF THE DRAFT ORDINANCE AMENDING CHAPTER II, SECTION 5, OF THE CITY CHARTER TO ESTABLISH A PROCEDURE TO SET THE FEE PAID TO CITY COUNCILOR MEMBERS FOR SERVICE AS A MEMBER OF THE CITY COUNCIL PASSES ON THE NOVEMBER 3, 2015 ELECTION BALLOT.

Lamkin: We need to set a date for our meeting, if the amendment passes on November  $3^{rd}$  to get together as a group and discuss the Commissions intentions about setting the proposed wage for City Councilors.

Clerk: I'm trying to think fast of any other groups that have standing meetings so can I have a backup date just in case there's a conflict for the room? The Council meetings are on the first two Mondays in December, so I think we'd want to make sure we get any recommendation to them sooner than later. The only requirement that I have, is a 20 day meeting notice. So, if the Charter Amendment passes on November 3<sup>rd</sup>, obviously I could send it out the meeting notice the next day. The first point is, concurrence that the Commission wants to meet to discuss this issue in a timely fashion. The second issue is the date for a special meeting.

Lamkin: There is a motion CONFIRMING THAT THE COMMISSION WANTS TO MEET IN A TIMELY FASHION, IF THE BALLOT ISSUE PASSES, which motion was seconded and carried unanimously.

Lamkin: There is motion that a SPECIAL CHARTER COMMISSION BE HELD ON DECEMBER 1<sup>ST</sup> OR ON NOVEMBER 24<sup>TH</sup>, AT 5 P.M., IF NEEDED, which motion was seconded and unanimously carried.
