PERMANENT EASEMENT AGREEMENT

THIS AGREEMENT, made this 2 day of 2018, by and between Therese H. Vaughn, a single person, ("Owner") and the City of Duluth, a municipal corporation under the laws of the State of Minnesota ("City").

WHEREAS, Owner is the owner of property described on Exhibit "A", attached hereto and made a part hereof, said real estate being located in the County of St. Louis, State of Minnesota (the "Property"); and

WHEREAS, the Property has as its southerly boundary, the northerly right of way line of Red Wing Street, as shown on the plats of Woodland Park, 2nd Division and Woodland Park, 2nd Division, 1st Rearrangement; and

WHEREAS, the City improved Red Wing Street as a public street in 1922 and Red Wing Street, as improved, has been in continuous use as a public street since constructed with public utilities existing within the Red Wing Street right-of-way, and

WHEREAS, it has now come to the City's attention that the improved Red Wing Street was not constructed within the platted right-of-way for Red Wing Street as shown on the plats of Woodland Park, 2nd Division, and Woodland Park, 2nd Division, 1st Rearrangement, but was in fact constructed over a portion of the Property; and

WHEREAS, the City has determined that an easement for street and utility purposes for that portion of Red Wing Street which was constructed over the Property has not been provided either by Owner or predecessors in title to Owner; and

WHEREAS, the City desires at this time to correct the records and file of record a street and utility easement for Red Wing Street as it was constructed and exists presently and Owner is willing and desirous of dedicating to the public a permanent easement for street and utility purposes for Red Wing Street..

NOW THEREFORE, in consideration of the mutual benefit of granting the street and utility easement to the public, Owner does hereby grant, bargain, sell and convey to the full extent of Owner's interest therein, to the City, its successors and assigns, for the benefit of the public, a permanent easement for street and utility purposes, in, under, over, upon, across and along that portion of the Property described on Exhibit "B", attached hereto and made a part hereof. That the easement hereby intended to be granted is depicted on Exhibit "C", attached hereto and made a part hereof.




