This amendment, effective as of the date of attestation by the City Clerk (the "Effective Date"), by and between the City of Duluth, hereinafter referred to as "City", and EPC Engineering & Testing located at 539 Garfield Avenue, Duluth, MN 55802, hereinafter referred to as "Consultant", for the purpose of rendering services to the City.

WHEREAS, on February 23, 2018, City and Consultant entered into an agreement bearing City of Duluth Contract No. L30037 for geotechnical and material testing services on a non-exclusive, project by project basis, which Contract has not been previously amended, hereinafter referred to as the "Contract"; and

WHEREAS, both parties desire to amend the Contract.

NOW THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth, the parties hereto hereby agree as follows:

In this Amendment changes in the language of the Contract which delete language will be shown as stricken and language added to the contract language will be underlined.

Revision 1. The Fees described in Section II of the Contract are hereby amended as follows:

It is agreed between the parties that Consultant's maximum annual fee for the term of years 2018, 2019 and 2020 of this Agreement shall not exceed the sum of Seventy-Five Thousand and no/100ths Dollars (\$75,000.00), and that Consultant's maximum annual fee for years 2021 and 2022 of this Agreement shall not exceed the sum of Fifty Thousand and no/100ths Dollars (\$50,000.00), for a total contract amount not to exceed of Three Hundred Twenty-Five Thousand and no/100ths Dollars (\$325,000.00), payable from various appropriate funds, departments, agencies, and objects, Project 1722. Fees for each service will be determined by the Consultant's current testing fee schedule, attached hereto as "Exhibit A". All invoices for services rendered shall be submitted monthly to the project manager, or his/her designee, and shall be accompanied by such documentation as the City shall reasonably expect. Upon receipt of said request and appropriate documentation, the City shall reimburse Consultant up to the amount set forth above.

In all other respects the contract, together with all of its terms, covenants and conditions, is hereby confirmed in its entirety.
