This amendment, effective as of the date of attestation by the City Clerk (the "Effective Date"), by and between the City of Duluth, Minnesota, hereinafter referred to as "Purchaser", and Venture Fuels, hereinafter referred to as "Seller", for the purpose of supplying coal to the Purchaser.

WHEREAS, on December 6, 2013, Purchaser and Seller entered into an agreement bearing City of Duluth Contract No. 22091 for Seller to supply Purchaser with sub-bituminous Coal from the Spring Creek mine for Duluth Energy Systems, which contract has been amended twice; and which contract and amendments are hereinafter referred to as the "Contract Agreement"; and

WHEREAS, both parties desire to further amend the Contract Agreement. Terms used in this Amendment shall have the meaning given in the Contract Agreement.

NOW THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth, the parties hereto hereby agree as follows:

The Contract Agreement shall be extended for an additional one (1) year term, commencing January 1, 2019 and terminating December 31, 2019, to deliver the remaining coal at the Superior Midwest Energy Terminal from the second unit train, as stated in the Second Amendment.

The delivered Base Price for Coal delivered in 2019 under this Amendment No. 3 shall be \$45.24 per net ton. The Base Price is based on the following components:

The Base Price shall be subject to adjustments per the terms contained in the existing Contract Agreement except the Rail Transportation component, included in the Base Price, shall be fixed for the term of this Contract Agreement.

In all other respects the Contract Agreement, together with all of its terms, covenants and conditions, is hereby confirmed in its entirety.
