This Work Order Contract is issued under the authority of the State of Minnesota, Department of Transportation (MnDOT) Master Partnership Contract No. 1028597 between the state of Minnesota acting through its Commissioner of Transportation ("State") and City of Duluth, a political subdivision of the State of Minnesota ("Local Government/Agency") and is subject to all applicable provisions and covenants of that Contract which are incorporated herein by reference.

#### **Work Order Contract**

#### Article 1 Term of Work Order Contract; Incorporation of Exhibits:

1.1	Effective date:	This Work Order Contract will be effective on the date that all required signatures are obtained by State, pursuant to Minnesota Statutes Section 16C.05, subdivision 2. The Local Government/Agency must not begin work under this Contract until ALL required signatures have been obtained and the Local Government/Agency has been notified in writing to begin such work by the State's Authorized Representative.
1.2	Expiration date:	This Work Order Contract will expire on April 30, 2019, or when all obligations have been satisfactorily fulfilled, whichever occurs first.

## Article 2 Nature of Work:

## Article 3 Scope of Work:

3.1 The State will perform services under this Work Order summarized generally as follows: State will acquire a consulting engineer's service for the purpose of creating a detailed plan set for the Duluth Metro Area EVP Signal Revisions at various trunk highway, county and city roadway locations along with specifications and any other documents required for a complete design package for the above mentioned project. Consultant <u>estimated</u> cost not to exceed \$49,605.00 will be split between all agencies based on project Signal Leg Ownership %'s. (Duluth = 60 %). Local Government/Agency's obligation to State based on Local Government/Agency's leg ownership % will not exceed twenty nine thousand seven hundred and sixty three dollars (\$29,763).

## Article 4 Items provided or completed by the Local Government/Agency.

4.1 The following will be provided or completed by the Local Government/Agency: The City of Duluth will provide project scoping which consists of as-built plans showing existing signal wiring diagrams, pole locations, conduit, control box locations, and handhole locations and the working condition of all these signal systems components. Scoping cost estimated at \$32,609.06 will be split between all agencies based on project Signal Leg Ownership %'s. (MNDOT = 24%). State's total obligation to Local Government/Agency

based on State's leg ownership % will not exceed seven thousand eight hundred twenty six dollars and 17 cents (\$7,826.17).

### Article 5 Consideration of Payment:

- 5.1 The Local Government/Agency will pay for all services performed by the State on an actual cost basis.
- 5.2 The balance of Local Government/Agency's obligation to the State, based on the work completed by State and Local Government/Agency under Articles 3 and 4 of this Agreement, is twenty one thousand nine hundred thirty six dollars and eighty three cents (\$21,936.83). The Local Government/Agency's actual compensation and reimbursements to the State for this work order will be invoiced upon State's final project consultant costs and the Local Government/Agency's final scoping costs.

### Article 6 Terms of Payment:

- 6.1 The Local Government/Agency will pay the State twenty one thousand nine hundred thirty six dollars and 83 cents (\$21,936.83) upon execution of this work order.
- 6.2 After the work has been completed, at the request of the Local Government/State Agency, the State will submit a signed report, and the signature will attest that the services have actually been performed.
- 6.3 Per Section 7.4 of the Master Partnership Contract;
  - 6.3.1 The Local Government/Agency will pay the State as specified in this work order, and will make prompt payment in accordance with Minnesota law.
  - 6.3.2 Payment by the Local Government/Agency.
    - 6.3.2.1 The Local Government/Agency will make payment to the order of the Commissioner of Transportation.

### Article 10 Termination.

- 9.1 Termination by the State or Local Government/Agency. The Local Government/Agency, the State or the Commissioner of Administration may cancel this Work Order at any time, with or without cause, upon 30 days' written notice to the other Party. Upon termination, the State will be entitled to payment, determined on a pro rate basis, for services satisfactorily performed.
- 9.2 Termination for Insufficient Funding. If the State is the Local Government/Agency, The State may immediately terminate this Work Order if it does not obtain funding from the Minnesota Legislature, or other funding source; or if funding cannot be continued at a level sufficient to allow for the payment of the services covered here. Termination must be by written or fax notice to the Local Government/Agency. The State is not obligated to pay for any services that are provided after notice and effective date of termination. However, the Local Government/Agency will be entitled to payment, determined on a pro rata basis, for services satisfactorily performed to the extent that funds are available. The State will not be assessed any penalty if the Work Order is terminated because of the decision of the Minnesota Legislature, or other funding source, not to appropriate funds. The State must provide the Local Government/Agency notice of the lack of funding within a reasonable time of the State's receiving that notice.

This written consent will in no way relieve the Local Government/Agency from its primary responsibility for performance of the work.
