* <u>Resolution No. 237 Award Light-Duty Paratransit Vehicles</u>: A motion was made by Director Gleeson and seconded by Secretary/Treasurer Zaruba Fountaine to approve the Board of Directors July 25, 2018 Resolution No. 222 concerning the purchase of 3 small minivans for STRIDE. After reviewing the independent cost-estimate and comparing the 4 proposals received, DTA staff determined the bid received from North Central Bus was the most responsive and responsible bid. Concerning the award of Light-Duty Paratransit Vehicles:

Whereas, the DTA has determined that Light-Duty Paratransit Vans are needed to provide STRIDE service for small occupancy ride requests and provide an adequate number of spare vehicles in the event of maintenance on other fleet vehicles:

Whereas, competitive proposals were sought and the DTA received four (4) responses; Whereas, after review of the responses, DTA staff determined that the proposed vehicle from North Central Bus fulfills the DTA's requirements and was priced fairly and reasonably; and Whereas, three (3) light-duty vehicles will serve current demand and provide a spare for the near term.

Now, therefore be it resolved, that the DTA Board hereby approves the contract for Light-Duty Paratransit Vehicles to North Central Bus Company, and the purchase of three (3) BraunAbility paratransit vans in the amount of \$47,599.00 each, for a total purchase of \$142,797.00.
