STREET AND UTILITY EASEMENT

This STREET AND UTILITY EASEMENT is made by J&T Kolar AHW Properties, LLC, a Minnesota limited liability company ("J&T") in favor of the City of Duluth, a municipal corporation created and existing under the laws of the State of Minnesota (the "City") for the benefit of the public as set forth herein.

RECITALS

A. J&T owns the real property in St. Louis County, Minnesota legally described as follows (the "Property"):

Lots 21 and 23, including vacated alley adjacent to Lots 21 and 23, Duluth Proper, First Division, West Third Street.

- B. J&T wishes to grant the City a street and utility easement over a portion of the Property for the benefit of the public and at no cost to the City (the "Easement").
- C. The location of the Easement is that portion of the Property legally described on the attached Exhibit A and depicted on the attached Exhibit B (the "Easement Area").

NOW, THEREFORE, for good and valuable consideration, J&T grants to the City, in trust for the benefit of the public, a perpetual easement for street and utility purposes over, under and across the Easement Area.
