#### 1. Tree Maintenance Personnel

- a. Describe who will do what, and what areas they are responsible for.

#### 2. Tree Watering Process

#### 7. Pruning

Newly planted trees should need little pruning, if they were properly cared for in the nursery. In the first year after planting, remove only dead or broken branches. In later years, weakly attached limbs can be removed, and corrective pruning can be done if needed. Describe how pruning will be done.

Tree planting should include a warranty from the nursery for replacement (due to poor condition or mortality). The grantee should be prepared to fully replace all trees that are in poor condition or die prior to inspection at the end of the project grant agreement, unless loss was due to natural disaster beyond the control of the project manager. I am writing to ask for your support for the City of Duluth's application to the Preparing for Emerald Ash Borer Community Forest Grant opportunity. I represent Duluth's 1th District, which includes Lakeside, one of the target areas.

As a City Councilor, I am aware that the cost to mitigate EAB in Duluth is significantly impacting other important city services. Lakeside is modest family neighborhood at the base of Hawk Ridge Bird Observatory. As the intermediary landscape between the steep hillside of Hawk Ridge and Lake Superior, it is especially important to replace missing trees to slow and control water entering Amity Creek, an impaired designated trout stream, and Lake Superior.

Lakeside is home to many young families with small children and the large, infected ash need to be removed for public safety. Further, we know that research has demonstrated the positive impact that trees and green spaces have the quality of life. Lakeside is one of the hardest hit neighborhoods and some streets have lost most of their trees. As a City Councilor I am familiar with the cost to mitigate EAB and how that cost impacts other important city services. The Lincoln Park neighborhood has struggled financially for decades and is home to many of Duluth's most at-risk youth and families. The housing stock is old and residents are cost burdened because of high heating costs and maintenance on older homes. The neighborhood is seeing a renaissance and it is important to that recovery that visitors and residents, as well as potential residents and business, experience the welcoming feeling that green spaces and trees provide. Research has demonstrated the positive impact that trees and green spaces have on perceptions of life quality as well as property value.

While Lincoln Park is not happy to lose the large ash trees that we have, public safety is our primary concern. There are many young families with small children and the large infected ash that can't be saved need to be removed. Lincoln Park is especially hard hit by EAB as it had far fewer trees than other Duluth neighborhoods. It is especially important, therefore, to remove the dangerous trees and get them replaced.

We are excited to support the City of Duluth for the **Preparing for Emerald Ash Borer Community Forest Grant** project.

Ecolibrium3's mission is to "lead and inspire change in our community toward an equitable and sustainable future." Our experience includes leading the flood recovery efforts in northeastern Minnesota and northwestern Wisconsin after the June 2012 floods, developing nationally recognized community-based environmental programs, serving as the convener in Lincoln Park neighborhood focused on the social determinants of health, and being the City of Duluth's community engagement partner for the restoration of Lincoln Park's urban forest.

Miller Creek is a priority watershed emptying into the St. Louis River/Lake Superior. We worked with the Urban Land Institute in 2015 to identify resilience strategies for the river and the low-income Lincoln Park neighborhood. At that time, increasing the water retention of land surrounding Miller Creek became a priority. Unfortunately, instead of increasing storage capacity, EAB threatens to significantly impact the landscape because 70% of the target area is ash.

The environmental impact and its alignment with Great Lakes and St. Louis River AOC delisting strategies makes this a strong application. The enhanced environmental justice components of completing this work in a vulnerable and disadvantaged neighborhood makes it even more important.


