Resolution 365 - Appointment of DTA General Manager

President Bransky explained the interview and selection process that occurred to hire the best qualified candidate for the DTA General Manager position. It is desirable for the DTA General Manager to be an employee of ATE of Duluth and report directly to the DTA Board of Directors. President Bransky, Directors Szukis and Banks were chosen to sit on the Selection Committee, and they interviewed (virtually) three applicants last week. Although all applicants had relevant transit experience, the Selection Committee determined that Rod Fournier is the most qualified applicant to perform the duties required of the General Manager and highly recommend that he be hired for this position effective August 1, 2021. Mr. Fournier accepted this offer of employment at a starting salary of \$140,000, and will continue to receive the same fringe benefits while serving as the Assistant General Manager. After some discussion, a motion was made by Director Gleeson and seconded by Vice President Watson to approve Resolution 365 requesting ATE of Duluth to offer Rod Fournier a contract of employment to serve as the DTA General Manager with the salary and fringe benefit package as discussed. Resolution passed unanimously.

### OLD BUSINESS (20 min.)

ATE Withdrawal Liability Update (A. Bransky)

President Bransky noted the legal advice received was excellent. Of all the choices presented to the DTA with respect to withdrawal liability, there is one thing pretty clear; if the current ATE Management of Duluth employees remain employees of that entity, liability withdrawal is not triggered even if ownership of that entity changes.

ATE of Duluth Ownership & Operation Structure Update (A. Bransky)

The sale of First Transit has been completed and they are now owned by EQT Infrastructure, a private equity firm and infrastructure investor. Next, the DTA Board of Directors must determine the owner of ATE Management of Duluth. Once this has been determined, the operation structure can be established. DTA staff have contacted Hanft Fride law firm to research the advantages and disadvantages of DTA owning ATE Management of Duluth or contracting with a management firm. In addition, General Manager Fournier reported he is waiting for a response from the Public Employees Retirement Association ("PERA") about what it means to be a public employee and the liabilities associated with being a public employee. In response to Secretary/Treasurer Banks, creating an employee-owned transit company would bring the DTA closer to the withdrawal liability risk. Manager Fournier is not aware of any employee-owned public transit agencies. Hopefully, more information can be shared at next month's Board of Directors meeting.
