RESOLUTION AUTHORIZING A CONTRACT WITH INSIGHT PUBLIC SECTOR, INC. FOR THE PURCHASE OF PERSONAL COMPUTERS AND ACCESSORIES, IN ACCORDANCE WITH THE CITY'S FOUR-YEAR REPLACEMENT PLAN, IN THE AMOUNT OF \$215,402.97.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to purchase personal computers and accessories from Insight Public Sector, Inc. in accordance with the City's four-year computer replacement plan in the total amount of \$215,402.97, payable as follows:

STATEMENT OF PURPOSE: The purpose of this resolution is to authorize the purchase of personal

computers and accessories from Insight Public Sector, Inc., in accordance with the City's four-year replacement plan, in the total amount of \$215,402.97. This annual purchase will cover scheduled computer replacements for various City departments.

Insight Public Sector, Inc. is a Minnesota state contract vendor that offers very competitive pricing. MN State Contract Release C-1046(5), contract 48192.
