CITY PROPOSAL:

STATEMENT OF PURPOSE: This resolution authorizes the purchase of twelve (12) months of software and data usage for the 375 units currently active in the GPS/AVL system at an annual cost per unit of \$330 each and a total annual cost of \$123,750.

The initial purchase and installation of the GPS/AVL system was approved by City Council on May 9, 2011, resolution 11-0225R. Since its implementation, the GPS system has increased the efficiency of fleet vehicles by reducing mileage and drive-time, reducing idle time and excess speed, providing the ability to dispatch utility vehicles based on their proximity to a work site, and resolving accident investigations more effectively.

In 2017 the City paid a per unit annual cost of \$336. The total contract cost in 2017 was \$126,000.
