RESOLUTION AUTHORIZING A CONTRACT WITH INSIGHT PUBLIC SECTOR, INC. FOR THE PURCHASE OF PERSONAL COMPUTERS AND ACCESSORIES, IN ACCORDANCE WITH THE CITY'S FOUR-YEAR REPLACEMENT PLAN, IN THE AMOUNT OF \$230,661.15.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to purchase personal computers and accessories from Insight Public Sector, Inc. in accordance with the City's four-year computer replacement plan in the total amount of \$230,661.15 payable as follows:

- \$13,041.65 110-700-1420-4639 (general fund, transfers and other functions, capital program, sale of equipment)
- \$83,572.85 250-015-2020-5580, CE250-E2001 (capital equipment, public administration, fiscal year 2020, capital equipment; capital equipment fund 250, enterprise wide pc/laptop replacements)
- \$2,247.00 250-015-2020-5580, CE250-E2007 (capital equipment, public administration, fiscal year 2020, capital equipment; capital equipment fund 250, network equipment replacements)
- \$28,317.00 250-015-2020-5580, CE250-E2010 (capital equipment, public administration, fiscal year 2020, capital equipment; capital equipment fund 250, EOC upgrade - fire)
- \$103,482.65 250-015-2021-5580, CE250-E2101 (capital equipment, public administration, fiscal year 2020, capital equipment; capital equipment fund 250, life cycle projects - IT)

STATEMENT OF PURPOSE: The purpose of this resolution is to authorize the purchase of personal computers and accessories from Insight Public Sector, Inc., in accordance with the City's four-year replacement plan, in the total amount of \$230,661.15. This annual purchase will cover scheduled computer replacements for various City departments.

Insight Public Sector, Inc. is a Minnesota state contract vendor that offers very competitive pricing and this purchase is through Contract 160328, Release C-1046(5).
