RESOLUTION AUTHORIZING PROPER CITY OFFICIALS TO ACCEPT A GRANT FROM THE UNITED STATES DEPARTMENT OF JUSTICE IN THE AMOUNT OF \$39,828 AND FURTHER AUTHORIZING EXECUTION OF GRANT AGREEMENT WITH ST. LOUIS COUNTY.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to accept a FY17 Justice Assistance Grant Program award from the United States department of justice, bureau of justice assistance, office of justice programs, in the amount of \$39,828 to be used for state and local initiatives including First Witness Child Advocacy Center, St. Louis County sheriff's department computer equipment and license purchases, and Duluth police department equipment purchases; and further are authorized to execute a grant agreement substantially the same as the attached exhibit A and to accept said grant, funds to be deposited in Revenue Fund # 215-200-2305-4209-02 (Duluth Police Grant Programs, Police, 2017 JAG, Direct Federal Grants Operating) and expenses to be paid from Expense Funds # 215-200-2305-5447 (Duluth Police Grant Programs, Police, 2017 JAG, Payment to Other Government Agencies) and # 215-200-2304-5580 (Duluth Police Grant Programs, Police, 2017 JAG, Capital Equipment).

FURTHER RESOLVED, that the proper city officials are hereby authorized to execute an agreement, substantially the same as the attached exhibit B, with the St. Louis County sheriff's office, who is a partner of the city under this grant.

STATEMENT OF PURPOSE: The Duluth Police Department is the designated recipient and fiscal agent of a FY2017 Justice Assistance Grant ("JAG") from the U.S. Department of Justice in the amount of \$39,828. The St. Louis County Sheriff's Office is a partner with the City under this grant as the "disparate" jurisdiction. The City will reimburse the St. Louis County Sheriff's Office \$8,615 and First Witness Child Advocacy Center \$5,000, as per the Scope of Professional Services located within document Exhibit B. The balance of the grant award, \$26,213 will be utilized by the Duluth Police Department for equipment purchases.

This resolution authorizes the acceptance of the grant award and approves the agreement with the St. Louis
