RESOLUTION AUTHORIZING AN AGREEMENT FOR THE PURCHASE OF A MULTI-JURISDICTIONAL LAW ENFORCEMENT RECORDS MANAGEMENT SYSTEM INCLUDING EQUIPMENT, SOFTWARE, IMPLEMENTATION SERVICES, TRAINING, MAINTENANCE AND SUPPORT FROM TYLER TECHNOLOGIES, INC. FOR A FOUR-YEAR PERIOD BEGINNING IN 2018 FOR AN AMOUNT NOT TO EXCEED \$1,144,871.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to enter into an agreement, substantially in the form attached as Exhibit A, for the purchase of a Multi-Jurisdictional Law Enforcement Records Management System from Tyler Technologies, Inc., including equipment, software, implementation services, training, maintenance and support for a four-year period for an amount not to exceed \$1,144,871, payable from the following funds:

STATEMENT OF PURPOSE: This resolution authorizes the purchase of a Multi-Jurisdictional Law Enforcement Records Management System from Tyler Technologies, Inc., including equipment, software, implementation services, training, maintenance and support for a four-year period for an amount not to exceed \$1,144,871.

The new comprehensive system will include many modules to enhance police operations. (Field Based Reporting, Property and Evidence, Citations, Animal Control, Citizen Reporting, Alarm Tracking, etc.) The system will enable officers and staff to more easily access information in the field. The ability to have this

access to critical information will result in operational efficiencies as well as increased officer safety.

The system also includes multi-jurisdictional capabilities that will allow partner agencies to utilize the system to gain operational efficiencies, and will support critical information sharing amongst the partner agencies. The new system will consolidate several disparate systems (Property and Evidence, Citations, Citizen Reporting, Alarm Tracking, etc.) into a single platform; reducing the number of interfaces and improving the overall management and maintenance of the systems. This new system will offer greater ease of use, information access capabilities, field based reporting tools, and shared information access at an annual maintenance cost that is less than current annual system maintenance costs.
