RESOLUTION AUTHORIZING PROPER CITY OFFICIALS TO ACCEPT A GRANT FROM THE UNITED STATES DEPARTMENT OF JUSTICE IN THE AMOUNT OF \$38,548 AND FURTHER AUTHORIZING EXECUTION OF GRANT AGREEMENT WITH ST. LOUIS COUNTY.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to accept a FY18 Justice Assistance Grant Program award from the United States department of justice, bureau of justice assistance, office of justice programs, in the amount of \$38,548 to be used for state and local initiatives including First Witness Child Advocacy Center, Domestic Abuse Intervention Program, Life House, St. Louis County sheriff's department FBI NIBRS compliance, and Duluth police department recruitment initiatives and FBI NIBRS compliance; and further are authorized to execute a grant agreement substantially the same as the attached exhibit A and to accept said grant, funds to be deposited in Revenue Fund # 215-200-2306-4209-02 (Duluth Police Grant Programs, Police, 2018 JAG, Direct Federal Grants Operating) and expenses to be paid from Expense Funds # 215-200-2306-5447 (Duluth Police Grant Programs, Police, 2018 JAG, Payment to Other Government Agencies), Fund # 215-200-2306-5241 (Duluth Police Grant Programs, Police, 2018 JAG, Small Equip-Office/Operating), and # 215-200-2306-5580 (Duluth Police Grant Programs, Police, 2018 JAG, Capital Equipment).

FURTHER RESOLVED, that the proper city officials are hereby authorized to execute an agreement, substantially the same as the attached exhibit B, with the St. Louis County sheriff's office, who is a partner of the city under this grant.

STATEMENT OF PURPOSE: The Duluth Police Department is the designated recipient and fiscal agent of a FY2018 Justice Assistance Grant ("JAG") from the U.S. Department of Justice in the amount of \$38,548. The St. Louis County Sheriff's Office is a partner with the City under this grant as the "disparate" jurisdiction. The City will reimburse First Witness Child Advocacy Center \$5,000, Life House \$5,000, and Domestic Abuse Intervention Program \$5,000 as per the Scope of Professional Services located within document Exhibit B. \$22,392 will be utilized by the Duluth Police Department for developing recruiting material. The balance of \$1,156 will be used by the Duluth Police Department and the St. Louis County Sheriff's Office toward

achieving full compliance with the FBI NIBRS data submission requirements under the UCR Program as per the FY 2018 BJA requirement. This resolution authorizes the acceptance of the grant award and approves the agreement with the St. Louis County Sheriff's Office.
