**CITY PROPOSAL:**

RESOLVED, that the proper city officials are hereby authorized to purchase personal computers and accessories from Insight Public Sector, Inc. in accordance with the City's four-year computer replacement plan in the total amount of \$315,422.82, payable as follows:
