RESOLUTION AWARDING A CONTRACT TO NORTHLAND CONSTRUCTORS OF DULUTH, INC. FOR THE DECKER ROAD REHABILITATION AND UTILITY RECONSTRUCTION PROJECT IN THE AMOUNT OF \$3,538,000.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to enter into a contract with Northland Constructors of Duluth, Inc. for the Decker Road Rehabilitation and Utility Reconstruction project in the amount of \$3,538,000, payable out of Permanent Improvement Fund 411, Department/Agency 035 (Capital Projects Accounts), Object 5530 (Improvements Other than Buildings), city project no. 0843TR, S.P. 118-178-006. Funding sources are MSA funds, Federal funds and local funds. Of the project costs, \$371,175 will be assessed to benefitting properties. In addition, the Western Lake Superior Sanitary District will reimburse the city for the work on their facilities in the amount of \$111,269.09.

STATEMENT OF PURPOSE: This resolution authorizes the Decker Road rehabilitation including construction of new water main, gas main, storm sewer structures, and a 1000' sanitary sewer extension between Piedmont Avenue and Mountain Shadow Drive by Northland Constructors of Duluth, Inc. in the amount of \$3,538,000. Northland Constructors was the lowest responsible bidder of the four companies that responded. The engineer's estimate was \$4,456,000. Payable out of Permanent Improvement Fund 411, Department/Agency 035 (Capital Projects Accounts), Object 5530 (Improvements Other than Buildings), city project no. 0843TR, S.P. 118-178-006, purchase order no. 19-0426.
