RESOLUTION AWARDING A CONTRACT TO KGM CONTRACTING, INC. FOR THE 2021 EAST SUPERIOR STREET RECONDITIONING PROJECT, FROM 45<sup>TH</sup> AVENUE EAST TO 60<sup>TH</sup> AVENUE EAST, IN THE AMOUNT OF \$2,547,829.96.

**CITY PROPOSAL:**

RESOLVED, that the proper city officials are hereby authorized to enter into a contract with KGM Contracting, Inc. for the 2021 East Superior Street Reconditioning project from 45<sup>th</sup> Avenue East to 60<sup>th</sup> Avenue East, in the amount of \$2,547,829.96. Payable from Permanent Improvement Fund 411, Department 035 (Capital Projects Accounts), Object 5530 (Improvements Other than Buildings), City Project no 1908, S.P. 118-147-019. The funding sources for the project will be Federal funds (\$1,360,000) and Municipal State Aid funds (\$400,000) and Street Improvement Sales Tax Fund 291 (\$787,829.96).

**STATEMENT OF PURPOSE:** This resolution will authorize award of a contract to KGM Contracting, Inc. in the amount of \$2,547,829.96 for the East Superior Street Reconditioning project from 45<sup>th</sup> Avenue East to 60<sup>th</sup> Avenue East. The engineer's estimate was \$2,794,212. Payable from Permanent Improvement Fund 411, Department 035 (Capital Projects Accounts), Object 5530 (Improvements Other than Buildings), City Project no. 1908, requisition no. 21-99501.
