UPDATES FROM STAFF

Howie Smith reported on various projects including design of the filter upgrades at the water plant, painting of water towers next year, generator resiliency at the water plant, the water main work on London Road, and plans for Woodland reservoir updates.

Cyndi Falconer reported that there are about 50 lead services left to replace this year. About 90% of the design projects are completed for next year. We are anticipating being able to replace 1,000 services next year. The annual letter to those with known lead or unknown services will go out in November.

COMMISSIONER QUESTIONS OR COMMENTS

Commissioner Crouse asked about wastewater and stormwater for the data center in Hermantown. Jim Benning replied that wastewater would go to WLSSD and any stormwater would be in Hermantown. That would not affect the City of Duluth system. An environmental document is available on the Hermantown website.

Vice President Medved asked if the gas system is ready for the winter season. Howie Smith replied that we are ready. Vice President Medved mentioned some work out in Gary. Howie Smith responded that corrosion evaluation of the transmission line must be done every seven years. It is holding up well so far.

UPCOMING COUNCIL ACTIONS

Jim Benning mentioned various resolutions for easements.
