WHEREAS, the City of Duluth, hereinafter referred to as "City", and MSA Professional Services, Inc., located at 332 West Superior Street, Suite 600, Duluth, MN 55802, hereinafter referred to as "Consultant", entered into an agreement bearing City of Duluth Contract No. L 31015 for providing the services of Catherine Hafdahl to the City of Duluth for her assistance with GIS for lead services inventory work, which was executed by the City on April 11, 2024, and which Contract has been previously amended one time, and is hereinafter referred to as the "Contract"; and

WHEREAS, both parties desire to reinstate the Contract so that it may be amended to allow Consultant additional time to complete its responsibilities as described in the Contract with additional hours of services as described in the Customer Account Statement which is hereby incorporated into the Contract and attached hereto as Exhibit C; and

NOW THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth, the parties hereby agree as follows:

In this Amendment changes in the language of the Contract which delete language will be shown as stricken and language added to the contract language will be underlined.

Revision 1. To reinstate the Contract and extend the termination date of the Contract to December 31, 2025, so that the Contract shall be considered to have been in effect from the effective date through December 31, 2025 under the same terms and conditions, except as amended herein.

Revision 2. The Agreement Period described in Section III.5. of the Contract is hereby amended as follows:

The term of this Agreement shall commence on the Effective Date and performance shall be completed by June 30, 2024 June 30, 2025 December 31, 2025, unless terminated earlier as provided for herein.

Revision. 3. The Proposal described in the fourth paragraph on the Contract is hereby amended as follows:

WHEREAS, Consultant submitted a proposal to provide services for the Project (the "Proposal"), a copy of which is attached hereto as Exhibit A; and amended by the proposal dated November

6, 2024, a copy of which is attached hereto as Exhibit B; <u>and amended by a Customer Account Statement</u>, dated September 16, 2025, a copy of which is attached hereto as Exhibit C; and

Revision 4. The Fees described in Section II. of the Contract is hereby amended as follows:

It is agreed between the parties that Consultant's maximum fee for the Project and Services shall not exceed the sum of Forty Thousand and 00/100 Dollars (\$40,000.00) Forty-Nine Thousand and 00/100 Dollars (\$49,000.00) Fifty-Four Thousand, Six Hundred Twenty-Two and 50/100 Dollars (\$54,622.50) inclusive of all travel and other expenses associated with the Project, payable from Fund 510-500-1930-2330-5310.

Either party may, by giving written notice, specifying the effective date thereof, terminate this Agreement in whole or in part without cause. In the event of termination, all property and finished or unfinished documents and other writings prepared by Consultant under this Agreement shall become the property of the City and Consultant shall promptly deliver the same to the City. Consultant shall be entitled to compensation for services properly performed by it to the date of termination of this Agreement. In the event of termination due to breach by Consultant, the City shall retain all other remedies available to it, and the City shall be relieved from payment of any fees in respect of the services of Consultant which gave rise to such breach.

In all other respects the contract, together with all of its terms, covenants and conditions, is hereby confirmed in its entirety.
